1. Eligibility.

St. Patrick's Day Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The St. Patrick's Day Kiosk Game starts at 9 a.m. Central Time (CT), and ends at 11:59 p.m. (CT) on March 17th, 2025. PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

All Players Club card members may play the **St. Patrick's Day Kiosk Game** after earning 500 same-day tier points March 17th, 2025. Guests must swipe their Players Club card into any promotional kiosk, enter pin number, and select the appropriate Promotion tile. Game is available 9 a.m. to 11:59 p.m. during the Promotion Period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

6. Drawing and Notification.

Guests can play the **St. Patrick's Day Kiosk Game** and win Reward Play during the Promotion Period after earning 500 same-day tier points on their club card. Game must be played the same day as points earned. PCH has the sole authority to determine the winners and such decisions are final. After earning 500 same-day tier points, guests can go to any Promotional Kiosk, swipe their card, put in their pin number, select Monthly Promotions then touch *St. Patrick's Kiosk Game* and have a chance to win Reward Play.

- Reward Play from the kiosk game is valid for 7 days after redemption.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners may be required to provide valid picture identification and a Players Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. Release, Publicity, Use of Personal Information.

PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
