Official Rules

1. Eligibility.

Club 50 Senior Day Kiosk Game is open to those fifty (50) years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 7:00 a.m. Central Time (CT), and ends at 11:59 p.m. (CT) each Wednesday during the months of April, February and June 2025.

PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee Location only.

All Players Club members fifty (50) years or older may play the **Club 50-Senior Day Kiosk Game**, after earning 100 tier points during the hours from 7:00 a.m. and 11:59 p.m., guests can then swipe their Players Club card into any promotional kiosk, enter their PIN, select Monthly Promotions and then touch “Senior Day”. Guests can participate up to 5 times each Wednesday. The Club 50 Senior Day Kiosk Game is available from 7 a.m. to 11:59 p.m. each Wednesday. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Eligible guests that sign up for a Players Club card will be eligible to participate that same day.

Earn Entries: Players Club members fifty (50) years or older who earn one hundred (100) tier points or more on Wednesday can swipe at the Kiosk and play the wheel spin game to receive a Reward Play offer. Guests can spin the wheel up to 5 times each Wednesday from the points earned that day.

The Club 50 Senior Day Kiosk Game will be available from 7:00 a.m. to 11:59 p.m. Guests can go to any promotional kiosk, swipe their card, enter their PIN, select Monthly Promotions and then touch “Club 50 Senior Day”. Points can only be earned starting at 7:00 a.m. and the game is also only available from 7:00 a.m. to 11:59 p.m. The kiosk game must be played the same day as points earned. Reward Play is valid for 7 days after redemption. PCH has the sole authority to determine the winners and such decisions are final.
