Official Rules

1. Eligibility.

Ride and Win Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, (“PCH”). Employees of (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 9:00 a.m. Central Time (CT) on April 7th, 2025, and ends at 11:59 p.m. (CT) on June 30th, 2025. Guests can participate in the Ride and Win Kiosk Game up to five (5) times per the following days:

- Monday, April 7th, 14th, 21st & 28th, 2025
- Monday, May 5th, 12th, 19th & 26th, 2025
- Monday, June 2nd, 9th, 16th, 23rd & 30th, 2025

PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee Location only.

All Players Club card members may play the **Ride and Win Kiosk Game**, after earning 200 tier points during the hours from 9:00 a.m. and 11:59 p.m. Guests must swipe their Players Club card into any promotional kiosk, enter pin number, and select the appropriate Promotion tile. Game is available 9:00 a.m. to 11:59 p.m. during the Promotion Period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Guest may play up to five (5) times each Monday during the promotional dates listed above.

Please note: The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is.” Any costs or repairs become the responsibility of the winners. Items are not redeemable for cash. **W-9 form** must be filled out for any cash/trip/prize over \$50. Winner must present a valid ID and Players Club card to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport or state ID card.

7. Drawing and Notification. After earning 200 tier points during the hours from 9:00 a.m. and 11:59 p.m., guests can play the Ride and Win kiosk game and potentially win Reward Play on Mondays in April, May and June 2025. Guests need to be present to win. Guests can play up to five times each Monday during the promotional period. To play the game after they earn the appropriate number of points, guests need to pick a vehicle each time they visit the kiosk. A wheel will spin showing the number of spaces they advance on the game board. If they land on the Bonus Round spot, another wheel will appear in which their Reward Play prize will be revealed. If they do not land on a Bonus Round spot, they do not win anything during that particular play. Choosing a vehicle and spins need to take place at the kiosks on the same day the 200 points are earned. Guests will continue on their game board from where they left off on their previous visit; Game resets after they complete a round. PCH has the sole authority to determine the winners and such decisions are final.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners may be required to provide valid picture identification and Players Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**

Entrants agree to release and hold harmless Potawatomi Bingo Casino, Potawatomi Hotel, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors and employees of each of them (“the Released Parties”) from and against any claim or cause of action arising out of participation in the Promotion, or acceptance or use of any prize, including but not limited to: (a) unauthorized human intervention in the Promotion; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Promotion or the processing of registrations and game plays; (e) late, lost or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Promotion or acceptance and use of any prize.
