1. Eligibility.

10x Points is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

All guests who are playing slots with their Players Club card can participate in the 10x multiple points promotion. Multiple points do not count towards player's card status or to multiple Players Club cards in use; multiple points will only apply to the initial card inserted.

Exclusions: Live Poker, Bingo, Electronic Slot Table Games, Live Table Games, Sports Wagering, and Video Poker are excluded from earning points toward this promotion.
